### **Advice Letter 8-E-A**

Re: Supplemental Programmatic Changes to Marin Clean Energy's 2015 Energy Efficiency Programs

Marin Clean Energy's ("MCE's") advice letter ("AL") 8-E was suspended on January 2, 2015. On February 12, 2015 Energy Division ("ED") requested a supplemental filing seeking additional clarifying information. This AL constitutes the supplemental filing and provides the requested information.

**Effective Date:** January 1, 2015

#### **Purpose**

ED suspended MCE's AL 8-E and requested supplemental filing by February 23, 2015. ED staff requested the supplemental filing include clarifying information to aid in the review of MCE's AL 8-E. ED specifically requested:

- Savings associated with mailers be identified as a per home treatment or per household treatment with savings coinciding with the duration of the treatment
- Inclusion of savings per project and number of projects for multi-family and custom projects
- Inclusion of the unit energy savings and the number of installs for deemed savings
- Specification of the unit energy savings and the number of units forecasted for installation on a quarterly basis
- Inclusion of adequate references to program data and consistency with MCE's Program Implementation Plan descriptions

This AL supplements MCE's AL 8-E filed on December 15, 2014 and incorporates the clarifying information requested by ED on February 12, 2015.

#### **Background**

Ordering Paragraph ("OP") 16 of Decision 14-10-046 (the "Decision"), *Decision Establishing Energy Efficiency Savings Goals and Approving 2015 Energy Efficiency Programs and Budgets (Concludes Phase I of R.13-11-005)*, requires Marin Clean Energy ("MCE") to file an AL

reflecting budget and programmatic changes adopted in that decision. MCE filed AL 8-E to comply with OP 16 on December 15, 2015.

AL 8-E was suspended on January 2, 2015 pending further review. ED issued a Notification of Need for a Supplemental Advice Letter Filing for Advice Letter 8-E ("the Notification") on February 12, 2015. This Notification outlined MCE's obligations under the Decision and included several specific requests for clarification. These requests are summarized above in bulleted format. MCE is filing this AL and updating its cost-effectiveness calculators as appropriate to comply with the Notification.

#### **Compliance with the Requests for Clarifying Information**

MCE is responding to ED's requests for clarifying information by updating a cost-effectiveness calculator that was filed as an appendix to MCE's AL 8-E. AL 8-E included two sets of appendices, one based on the approved 2015 program budget and one based on a proposed budget extension. MCE received a preliminary determination from ED that the budget extension requested in MCE's AL 8-E will be denied without prejudice. As a result, this supplemental filing provides updates based only on the approved 2015 budget.

The updates were made to the 2015 Roll Up Including Non-Resource cost-effectiveness calculator filed as Appendix D in MCE's AL 8-E. This revised appendix is included in this supplemental filing as Attachment 1: Revised Appendix D. MCE made the following changes based on ED's requests:

- Replaced all installation schedule quantities based on kWh savings with number of projects and adjusted per unit savings accordingly.
- Updated program participation forecasts to better align projections with historical program participation information. These forecasts were developed based upon the average savings per project thus far in the MCE small commercial program.
- Replaced the direct install CFLs in the multifamily program with LEDs.

This information and the corresponding updates reflected in Attachment 1 are intended to respond to the issues raised in the Notification and enable ED to complete review and approve MCE's AL 8-E.
