



# Solar Rebate Application for Income-Qualified Multifamily Residential Properties

The MCE Multifamily Income-Qualified Photovoltaic Rebate Program (Program) was developed to reduce the cost of photovoltaic (PV) solar systems on multifamily properties and benefit low-income tenants directly from electricity bill savings. The maximum rebate available through MCE is up to \$1.50/Watt (AC) and may change depending on customers receiving the Solar Investment Tax Credits (ITC) and/or the Low-Income Housing Tax Credit (LIHTC). The Program standardizes projects by requiring the CEC-AC output rating from the California Solar Initiative Solar Calculator (Program Rebate)<sup>1</sup>. More information on rebate rates can be found in Table A below.

## Eligible Properties

To be eligible for the rebate, the property owner must meet the following requirements:

1. Property must be an existing building with 3 or more units;
2. Property is income-eligible:
  - A Deed Restricted property with at least 66% of households at or below 80% the Area Medium Income (AMI)<sup>2</sup>, **OR**
  - A property with a non-profit housing developer that can provide documentation that at least 66% of households are at or below 80% AMI, **OR**
  - The property has completed MCE's Low-Income Families and Tenants (LIFT) income verification process.

3. The meter account tied to the solar system is enrolled into MCE's service;
4. The PV system must be purchased and/or building permits signed after 4/1/20. MCE will not accept applications for rebates once funds are exhausted and/or after the Program is completed on 3/31/21; **AND**
5. Properties must be non-participants in Solar on Multifamily Affordable Housing (SOMAH)<sup>3</sup> program or Low-Income Weatherization program (LIWP)<sup>4</sup>. MCE recommends looking into these programs prior to filling out MCE's form as they provide larger incentives than MCE currently can offer. More information on these programs can be found in the "Other Available Programs" section below.

### How to Apply for a Program Rebate

Submit the following materials to MCE to be considered for a Program Rebate:

1. Completed Property Owner Application for the MCE Multifamily Income-Qualified PV Rebate Program (see Page 5 below);
2. Residents Benefits Proposal: A written proposal, from the property owner stating how tenants will benefit from the installed PV system.
  - If tenant accounts are to receive 50% or more of the financial benefit from the system output provided by PV generation, property owners shall provide the allocation sheet that indicates which meters will be offset through the PV output.
  - If tenant accounts are to receive less than 50% of the financial benefit from the PV generation, property owners shall describe how the electricity bill savings will be reinvested in the property in a way that provides benefits to existing tenants.
3. Documentation showing property is income-eligible;
4. Documentation showing the metered account tied to the PV system is enrolled in MCE service;
5. Documentation showing the PV system was purchased and/or building permits signed after 4/1/20.
6. A print out of the California Solar Initiative (CSI) EPBB Standard PV current calculator analysis (<http://www.csi-epbb.com/default.aspx>) and provide all documents that verify the inputs used in the calculation (PV Module type, number of modules, mounting method, inverter type, number of inverters, array tilt and array azimuth).

## Application Evaluation Process

Each application will be evaluated to verify the property is eligible and to determine which property provides the most benefit to its tenants from the installed PV system to receive the rebate. The benefit to tenants, as described in the proposal submitted with the application, will be evaluated on one of the following applicable criteria:

1. Benefit to tenant is directly through allocation of PV system output to tenants:
  - 50% of the system output is allocated equally to all tenants of the property.
2. Benefit to tenant is through some other reinvestment of energy bill savings in the property as described in the written proposal:
  - Does the proposal reasonably benefit tenants? For example, a property will invest in property safety improvements, undertake an energy efficiency project or construct a community garden.
  - How likely is the cost of the proposal to be reasonably covered by the electric bill savings generated from the PV system, i.e., the PV Project Return?

MCE will estimate bill savings using the estimated annual kWh output of the PV system, MCE's current Residential E1 electricity rate and the cost of installing the system to estimate lifetime benefits to the property owner over an estimated 30-year equipment life.

$$\text{Cost of System} - (\text{Lifetime kWh Output}) * (\$0.068/\text{kWh}) = \text{PV Project Return}$$

MCE will reserve rebate funds for properties that have been selected based on the design of the PV system (PV Module type, number of modules, mounting method, inverter type, number of inverters, array tilt and array azimuth) in the application.

## System Verification

Once construction is complete, the property owner must submit to MCE:

1. An updated CSI-EPBB calculator output as well as supporting documentation for technology types used to verify the details of the system as built.
2. Proof of Project Completion: Permission to Operate (PTO) letter from PG&E.

MCE will review the submitted documents and once the system has been verified, MCE will mail a rebate check to the property owner.

## Receiving the Rebate

It will take approximately 30 days from the time MCE completes the system verification to the time you receive your rebate check in the mail. You will be notified as soon as your rebate has been processed for payment. MCE will send a rebate check based on the installed system configuration.

## Other Available Programs

Solar on Multifamily Affordable Housing (SOMAH) and Low-Income Weatherization program (LIWP) are programs providing solar incentives. MCE strongly recommends properties look into these programs as they provide larger financial incentives than MCE can currently offer.<sup>5</sup> SOMAH's max incentive for offsetting tenant load is \$3.20 / Watt and \$1.10 / Watt for common space load. LIWP will provide about \$3.00 / Watt for offsetting tenant load and \$1.50 / Watt for common space load.

## Other Available MCE Programs

If tenant accounts will not receive a financial benefit through credit offsets, property owners shall describe how the electricity bill savings will be reinvested in the property in a way that provides benefits to existing tenants. MCE'S MULTIFAMILY INCOME-QUALIFIED PHOTOVOLTAIC REBATE PROGRAM TERMS AND CONDITIONS

1. **ELIGIBILITY:** The MCE Multifamily Income-Qualified Photovoltaic Rebate Program (Program) was developed to reduce the cost of photovoltaic (PV) solar systems in multifamily properties while benefiting low-income tenants. The Program offers rebates based on the CEC-AC output rating from the California Solar Initiative Solar Calculator located here: <http://www.csi-epbb.com/default.aspx>. Property owners, or their authorized representative, (Customer), can apply for the Program rebate for their installed system. To be eligible for the rebate, a property must be: (i) income-qualified (a Deed Restricted property with at least 66% of households at or below 80% The Area Medium Income (AMI), a property with a non-profit housing developer that can provide documentation that at least 66% of households are at or below 80% AMI, **OR** the property has completed MCE's Low-Income Families and Tenants (LIFT) income verification process), (ii) have the meter account, that is tied to the solar system, enrolled in MCE's service, and (iii) be for a PV system purchased and/or building permits signed after 4/1/20.
2. **QUALIFYING PROJECTS AND MEASURES:** Qualifying projects include PV solar system installations identified on eligible properties by MCE based on this application.
3. **OWNER APPLICATION/PARTICIPATION AGREEMENT:** By signing this form, Customer authorizes MCE, and/or MCE's authorized contractors, to enter Customer's premises for the purposes of conducting an assessment of the building's common area and individual units and evaluating the performance of installed measures, if Customer has elected to receive an energy assessment from MCE. Customer is responsible for providing required notices to each unit to allow MCE's technical assistance provider to enter the premises.
4. **REBATE AMOUNTS:** The amounts of the rebate for which qualifying projects are eligible will be determined on a project by project basis and will be issued once the installed system specifications are final and verified by MCE. Rebates are subject to change and are available until funds are exhausted and/or the Program is terminated. MCE will reserve rebate funds for properties that have been selected in the application process based on the design of the PV system (PV Module type, number of modules, mounting method, inverter type, number of inverters, array tilt and array azimuth).
5. **PV SYSTEM VERIFICATION REQUIRED:** Customer understands that Customer will not receive a rebate until the system verification documents have been verified and approved by MCE and/or its program implementers.
6. **ANNUAL VERIFICATION FOLLOW UP:** MCE reserves the right to follow up with the property 1 year after the rebate was mailed to ensure tenants are benefiting or to ensure the property is moving forward with their plan as indicated when this form, and supplementary documents, were submitted to MCE staff. If it is found that tenants are not benefiting, or the proposal is not being carried out as planned, MCE reserves the right to request and receive a return payment from the property for the same amount MCE provided in the original rebate.
7. **CLAW BACK RIGHT:** MCE reserves the right to request and receive rebate funds provided through this program if it is found that the property received incentives from SOMAH or LIWP or received tax credits that were not previously disclosed on the original form. MCE has a limited amount of funding so it is important to ensure that those funds are distributed to the properties and customers most in need.
8. **IMPLEMENTATION OF WORK AND PAYMENT OF REBATES:** Customer will be required to submit their PV system verification documents upon project completion, including an updated CSI-EPBB calculator output as well as the supporting documentation for the calculator output, and the Permission to Operate letter from PG&E. The maximum rebate amount issued is the amount confirmed in the Rebate Reservation form, unless otherwise approved in writing by MCE.
9. **CUSTOMER INFORMATION:** Customer authorizes MCE to collect and remit utility information including owner and tenant name, account number, electric, gas, and/ or water consumption data and electric, gas, and/or water savings to a third-party evaluation contractor for Program evaluation purposes. The evaluation contractor will keep customer information confidential. Customer information may also be provided to the CPUC and/or MCE's authorized contractors including the technical assistance provider. The Customer agrees that MCE and MCE's authorized contractors may review the building's historic and future energy data to evaluate, measure, and verify actual system performance.



10. **TAX LIABILITY and CREDITS DISCLAIMER:** MCE is not responsible for any taxes which may be imposed on the customer as a result of measures installed under this Program. Customer is responsible for consulting its own tax advisor as to the tax consequences of the rebate issued under this Program as well as any future system output credits on the metered account.
11. **DISPUTES:** Except where otherwise limited by law, MCE reserves the right, at its sole discretion, to make final determinations regarding any disputed issues about the Program, including but not limited to eligibility and incentive or rebate amounts.
12. **PROGRAM CHANGES:** MCE reserves the right to change, modify, or terminate this Program at any time without any liability except as expressly stated herein. MCE will honor all written commitments made in the Rebate Reservation provided to Customers prior to the date of any change, modification or termination of this Program, provided that project installations are fully completed within the time specified in the Rebate Reservation.
13. **PROGRAM EXPIRATION:** The Program will expire upon the earliest to occur: (i) March 31, 2020, (ii) when funds are depleted, or (iii) when the Program is terminated.
14. **DISCLAIMER:** MCE makes no representations or warranties, expressed or implied, and does not guarantee that the use of the equipment purchased or installed pursuant to this Program will result in energy cost savings.
15. **INSTALLATION REQUIREMENTS:** All work must be performed and completed in accordance with applicable laws, rules, and regulations of local, state or federal authorities having jurisdiction, including but not limited to licensing and permitting requirements. Any removal or disposal of old equipment, materials or debris as necessary to complete the project scope of work shall be done in accordance with all applicable regulations. The contractor selected by Customer shall be solely responsible for the work of any and all subcontractors.
16. **WARRANTY:** The contractor selected by Customer to install measures must provide a warranty for all labor and materials furnished or performed under this Program for Customer from defects in workmanship for a period of at least twelve (12) months after installation is completed. The warranty period shall commence on the date of Customer's signature on a contractual agreement with the contractor. During the warranty period, the contractor shall provide replacement materials and the necessary labor (at no additional cost to MCE or Customer) to replace the defective materials and repair incorrectly operating equipment. The contractor selected by Customer shall be solely responsible for the work of any and all subcontractors.
